Foreman - working member that supervises 5 or more members. General Foreman - OSHA 30 cert; supervises more than one foreman led crew.

\*AGC Welder Premium is \$1.75 per hour over their group's journeyman wage rate. Minimum of 8 hours per day.

\*GCCA Welder Premium is 5% over their group's journeyman wage rate. Minimum of 8 hours per day.

### Note:

1) Overtime is paid using the Taxable Wage (Taxable Wage X Overtime Rate) then the taxable deductions (Dues and Vacation) are deducted.

2) Training Contributions are based on 1.7% of the Group 1 Journeyman Carpenter gross wage (Taxable + Fringe).

3) Fringe Benefits are to be paid on all hours worked (with the exception of Pension for 1st and 2nd term Carpenter Apprentices -Article 27) in addition to the taxable wage rate.

4) Apprentices in the 1st and 2nd periods, when working on any State or Federal Prevailing wage projects shall have their Pension Fund contributions paid in full at the managing trust.

Contractors signatory to AGC Agreements must pay UCG \$0.05

Contractors signatory to GCCA Agreements must pay \$0.02 to CMF
